Agenda Item	Discussion/Outcomes	Action
General Business	 Representative from Narrabri Local Aboriginal Land Council (NLALC) provided a Welcome to Country. NLALC representative tendered an apology to People for the Plains (PFTP) representative for comment at the last meeting which was accepted, recipient advised that he hadn't been concerned about comment. The Chair welcomed David Scilley as the new representative of NSW Farmers following election as President of Narrabri Branch and acknowledged Matt Norrie's contribution to the committee over his term. Tony Pickard advised that he will return as representative for PFTP at future meetings Representative from NLALC noted that the Native Title group does not have a representative from Narrabri and that members should be aware of the two tiered land process with State and Federal jurisdictions in NSW. General discussion amongst members of their experience and/or perception of the filming of the SBS Insight program titled <i>Power Divide</i> and the final program that was broadcast on SBS on 29 May 2018. PFTP member advised that documents tabled at last meeting were not in final format and requested Secretariat to redistribute to members in order. General discussion on NSW Water Division monitoring bore program and a member provided an update from his discussions with the Division. A request will be progressed with NSW Water for a date for the briefing to CCC as a future agenda item. 	Secretariat DPE
Santos Operations Update	 Santos Monthly Activity Update for June 2018 was distributed in hard copy to members and emailed out of session on 8 June 2018. The May 2018 update was emailed out of session to members on 11 May 2018. A Santos representative advised that a submission will be made to NSW Government to enable additional gas from some wells in PEL 238 to go to the Wilga Park Power Station which would reduce flaring. There was a general discussion between community members and government representatives on approvals and capacity of WPPS to generate electricity for the grid as well as on renewables and base load power more broadly in NSW. A Santos representative advised that the offer from Harbour Energy Ltd to acquire Santos shares had been rejected and Santos had now terminated discussions with the company. A member asked if there were other companies that may come on board for the Narrabri Gas Project and Santos representative advised that Energy Australia is currently a joint venture partner in the project. A member requested that Santos provide a presentation to the CCC such as was made to the Narrabri Shire Council in February 2017 in relation to employment from the project in the Narrabri area. There was discussion about opportunities for local people in the mining and natural gas industry, employment associated with wind and solar farms and opportunities for generation of electricity in the local area.
