SANTOS UPDATE – September 2014

Proposed upcoming work program – Narrabri Area

Time frames are indicative as schedules are dependent on factors such as approval times, weather and rig availability.

Decommissioning of wells:

- There are no plug and abandon activities planned for September

Workovers:

- The workover rig is continuing work on the Dewhurst pilot wells during September
- The workover rig is being used to install and/or maintain pumps on existing wells

Drilling of exploration core holes:

- There are no core hole activities planned for September

Pilot wells:

- There are no pilot well drilling activities planned for September

Leewood:

- Construction of the ponds at Leewood is now complete and construction equipment and facilities are being decommissioned from the site
- Transfer of water from the Tintfield pond and Bibblewindi pond 3 to Leewood has been completed

Other work:

- Bibblewindi West, Bibblewindi East and Tintfield pilots are now on-line
- Wilga Park Power Station has been commissioned and is now in operation
- Clean out of the sediment in the now empty Tintfield pond 2 is complete and similar clean out of the sediment from Bibblewindi 3 pond has commenced
