Proposed upcoming work program – Narrabri Area

Time frames are indicative as schedules are dependent on factors such as approval times, weather and rig availability.

Decommissioning of wells:

 There are no plug and abandon activities planned for August

Workovers:

- The workover rig is continuing work on the Bibblewindi East pilot wells during August
- The workover rig is being used to install and/or maintain pumps on existing wells

Drilling of exploration core holes:

 There are no core hole activities planned for August

Pilot wells:

• There are no pilot well drilling activities planned for August

Leewood:

- The transfer of water from the Tintsfield pond to Bibblewindi pond 3 and then to Leewood has commenced
- Installation of the liner to pond 2 is continuing
- The Review of Environmental Factors (REF) for the proposed Leewood Phase 2 will be lodged in August
- The proposed activity involves the construction of treatment facilities for produced water and brine at Leewood

Other work:

 Wilga Park Power Station remains off-line as pilot wells are not flowing gas whilst workover program is undertaken
