Santos Activities Update December 2016



SANTOS UPDATE – December 2016 Proposed upcoming work program – Narrabri Area (PEL 238)

Time frames are indicative as schedules are dependent on factors such as approval times, weather and rig availability.

References to pilot wells are grouped in well sets as follows: Bibblewindi East includes Bibblewindi 12 – 21 & 27 - 29; Bibblewindi West includes Bibblewindi 22 – 26. Bibblewindi 9 Spot includes Bibblewindi 3 – 9; Dewhurst North includes Dewhurst 6, 22 – 25; Dewhurst South includes Dewhurst 26 – 29

Decommissioning of wells:

There are no plug and abandon activities planned for December

Workovers:

 There are no workover activities planned for December

Drilling of exploration core holes:

 There are no core hole activities planned for December

Pilot wells:

 Bibblewindi East, Bibblewindi West, Dewhurst South and Tintsfield pilot wells are on-line

Leewood:

 Work has commenced on the installation of irrigation infrastructure at Leewood as part of the approved Leewood Produced Water Treatment and Beneficial Reuse Project. A centre-pivot irrigator will be installed on the eastern side of the Leewood property with work expected to be completed by end of March 2017.

Other work:

- The Wilga Park Power Station is on-line. The power station will be turned off for approx. one week in January 2017 for annual maintenance and servicing
- An application has been made to the NSW
 Department of Planning & Environment to modify
 the current approved project to enable the future
 use of gas from the Tintsfield Pilot at the Wilga
 Park Power Station. More information is available

- Rehabilitation is continuing at legacy sites, including revegetation activities at Bibblewindi
