SANTOS UPDATE – March 2017 Proposed upcoming work program – Narrabri Area (PEL 238)

Time frames are indicative as schedules are dependent on factors such as approval times, weather and rig availability.

References to pilot wells are grouped in well sets as follows: Bibblewindi East includes Bibblewindi 12 – 21 & 27 - 29; Bibblewindi West includes Bibblewindi 22 – 26. Bibblewindi 9 Spot includes Bibblewindi 3 – 9; Dewhurst North includes Dewhurst 6, 22 – 25; Dewhurst South includes Dewhurst 26 – 29

Environmental Impact Statement (EIS):

- The Project is currently on public exhibition by DPE and opportunity for public submissions is available until 24 April 2017

Western Slopes Pipeline:

- APA Group is undertaking preliminary studies for construction of the Western Slopes Pipeline to connect natural gas from the proposed Narrabri Gas Project to the Moomba-Sydney Pipeline.
- APA will submit a Preliminary Environmental Assessment to DPE to apply for approval to carry out State Significant Infrastructure. The document will be available when it is released on the DPE website at www.majorprojects.planning.nsw.gov

 Bibblewindi East, Bibblewindi West and Dewhurst South pilot wells are on-line Tintsfield pilot off-line for maintenance in early March

Leewood:

- Work has been completed on the installation of irrigation infrastructure at Leewood as part of the approved Leewood Produced Water Treatment and Beneficial Reuse Project
- Irrigation activities will not proceed until the outcome of the Court of Appeal hearing referred to below is known

Other work:

- The Wilga Park Power Station is on-line
- Rehabilitation is continuing at legacy sites, including revegetation activities at Bibblewindi
- Monitoring activities for regional baseline groundwater assessment are ongoing

 On 1 November, the Court of Appeal heard the case, brought by the Environmental Defenders Office acting for the People for the Plains, that the approval of Santos' Leewood Phase 2 project was invalid. The challenge was previously rejected by the Land and Environment Court in August 2016. The outcome of the appeal is pending.
