#### **About the CCC**

The Narrabri Gas Project Community Consultative Committee (CCC) brings together community, industry, local and state governments to explore and discuss issues relating to the exploration and extraction of CSG in the Gunnedah Basin.

Chaired by the NSW Land and Water Commissioner, members of the dialogue include Narrabri Shire Councillors and officers, independent community members, senior Santos representatives and senior agency officers from the Office of Coal Seam Gas (OCSG), the Division of Resources and Energy (DRE), the NSW Environment Protection Authority (EPA), the NSW Office of Water (NOW) and the Department of Planning and Environment (DP&E).

Item 2	EPA to formally present detail of their responsibilities
Item 3	Santos to provide an electronic copy of the Drilling and Well Integrity presentation
Item 4	Santos to provide link to ISO (International Organization for Standardization) Well Integrity document
Item 5	NSW Office of Water to present Groundwater Monitoring in the Gunnedah Coal Basin
Item 6	People for the Plains document request: Exploration Report 'Confidential file'
Item 7	Santos to distribute the Santos Bushfire Management Plan to NGP CCC members

Santos provided their monthly operations update. Santos reiterated that the Santos Bushfire Management Plan will be available at NGP CCC #8.

Statements were made by CCC members regarding questions asked of the NGP CCC and the purpose of the NGP

Also discussed was the submission process regarding the REF assessment process. It was noted that there is no mandatory timeframe to have an assessment completed, and that there is one government agency that makes the determination: DRE.

The Santos ENSW Manager Drilling and Completions presented on Drilling and Well Integrity. The presentation was well-received by committee members and generated insightful discussion. A copy of the presentation will be made available to all NGP CCC members.
