Santos provided their monthly operations update for the month of August.

The issue of receipt of formal community submissions to government document exhibition was raised with discussion focusing on the possibility of formal acknowledgment of submissions being implemented.

Plug and abandoning (P&A) of CSG wells was discussed with DRE stating that there will be a document prepared on P&A in the near future.

Santos provided an update on the Leewood Produced Water Treatment and Beneficial Reuse Project. Further updates will be provided by Santos on a monthly basis.

The EPA stated that the investigation into the March 2014 incident was complete.

It was noted that information held on the NSW Government DIGS database is inconsistent with the Common Ground application.
