SANTOS UPDATE – January 2017 Proposed upcoming work program – Narrabri Area (PEL 238)

Time frames are indicative as schedules are dependent on factors such as approval times, weather and rig availability.

References to pilot wells are grouped in well sets as follows: Bibblewindi East includes Bibblewindi 12 – 21 & 27 - 29; Bibblewindi West includes Bibblewindi 22 – 26. Bibblewindi 9 Spot includes Bibblewindi 3 – 9; Dewhurst North includes Dewhurst 6, 22 – 25; Dewhurst South includes Dewhurst 26 – 29

### **Environmental Impact Statement (EIS):**

- Santos hopes to submit the Narrabri Gas Project EIS to Government in the near future
- The EIS is a document required to identify and address potential impacts of the proposed Project. It will include extensive studies, with modelling and data on areas including water, flora, fauna, soil, noise, air quality, cultural heritage and social impacts

#### **Decommissioning of wells:**

• There are no plug and abandon activities planned for January

#### Workovers:

• There are no workover activities planned for January

#### Drilling of exploration core holes:

• There are no core hole activities planned for January

#### **Pilot wells:**

• Bibblewindi East, Bibblewindi West, Dewhurst South and Tintsfield pilot wells are on-line

#### Leewood:

 Work is continuing on the installation of irrigation infrastructure at Leewood as part of the approved Leewood Produced Water Treatment and Beneficial Reuse Project. A centre-pivot irrigator will be installed on the eastern side of the Leewood property with work expected to be completed by end of March 2017

#### Other:

• On 1 November, the Court of Appeal heard the case, brought by the Environmental Defenders Office acting for the People for the Plains, that the approval of Santos' Leewood Phase 2 project was invalid. The challenge was previously rejected by the Land and Environment Court in August 2016. The

outcome of the appeal hearing is expected after the Court Term recommences in February 2017

- The Department of Planning and Environment is seeking feedback on its proposed social impact assessment guidelines for State significant mining, petroleum production and extractive industry development with submissions closing on 3 March 2017. A number of information sessions will be held across NSW that explain draft guidelines, and what they will mean for future resource projects in regions, with a session being held in Gunnedah on 6 February 2017. - The Department of Primary Industries and Department of Public Works are progressing work on a new water monitoring bore site near Plumb Road (just off Pilliga Way) in the Pilliga East State Forest south of Narrabri to expand the groundwater monitoring bore network as part of the *Water Monitoring Strategy for Coal Basins in NSW* programme
- The NSW Government has launched the first stage of a new online portal that offers public access to NSW environmental data. The Sharing and Enabling Environmental Data (SEED) portal currently includes 70 sets of data from nine different NSW Government agencies, with further data sets to be added during the next stage of the portal's development.
