Agenda Item	Discussion/Outcomes	Action
Department of Planning and Environment (Division of Resources and Geoscience) – Gas Community Benefit Fund	 Diane Crosdale, Director Resources Policy from DRG provided the committee with an update on the status of the Gas Community Benefit Fund. The guidelines were developed when AGL at Camden was the only producing gas field. DRG acknowledge that current guidelines do not address feedback received from Local Government and community members and will need to be amended over time. No decision will be made on the fund until the final assessment has been determined for the Project. The fund is voluntary and there is no compunction under the Petroleum Onshore Act for a company to establish the fund, however there is a commitment in the EIS from Santos to do so. All of this will be considered by the Independent Planning and Assessment Commission in their consideration of the Project as the consent authority. DRG advise that guidelines won't be finalised until there's an application which resulted in discussion amongst members that it would be best to work out the structure and how the fund would work now so that it's clear and ready to go if/when the fund is established. A member asked whether the commitment from Government to match funding dollar for dollar was money going into the fund or just a discount on royalties — DRG advised it was dollars contributed up to the value of 10% of royalties to match what is contributed by the proponent. A member commented that in their view the fund should be a 'future fund' as a better long-term option for the community than dispersing funds on an annual basis. There was a comment that contributing funds to the capital cost of a project doesn't factor in the ongoing operational costs and referred to Broken Hill as an example with capital projects leaving the community with an operational cost liability. DRG representative said that the current guidelines only allow for capital funding, not operational or recurrent funding. Comment from member that Narrabri Shire Council's 10 year Strategic Plan would be suitable to help guide inve	
Santos Operations Update	 Santos Monthly Activity Update for July 2018 was distributed in hard copy to members and emailed out of session on 4 July 2018. A member stated that Modification 6 for the Narrabri Coal Seam Gas Utilisation Project was not clear that it was only for the wells Dewhurst 26-31 and the Tintsfield wells and that it could be interpreted to be for all wells in PEL 238. A Santos representative advised that the modification application was clear that it was only for the Dewhurst 26 – 31 and Tintsfield wells. A DPE representative advised that DPE only considered the twelve wells that Santos had listed in the application and it did not apply to all wells in PEL 238. A member advised that a NSW Water representative had advised him that they were installing water level monitors in the Government monitoring bores on Plumb Road. The member referred to the Groundwater Modelling Plan from 2006 and commented that he doesn't consider that the flow direction from Aquifer Monitoring Bores had been 	

	 Measured. A member referred to a paper presented to the Scientific Inquiry into Hydraulic Fracturing in the Northern Territory Fracking that stated that the presence of hydrogen sulphide may affect casing. Hunter New England Health - Update	 Dr Craig Dalton from NSW Health, Hunter New England Local Health District provided an overview of NSW Health's approach to assessment of health impacts associated with mining and gas industry. NSW Health focus on identifying the issues and assess hazards and exposure pathways and risk evaluation. Spoke about emissions and their potential health risk. NSW Health provided response to the Narrabri Gas Project EIS which is on DPE website. Happy for committee members to contact Hunter New England Health for further information as consider that uncertainty is one of the biggest problems and happy to help community find information. EPA will send through the link to the committee to the air monitoring data that is publicly available for this area (monitoring station at airport). GISERA health project in first phase only of planning the study, there has not been a commitment for the next phase of the project as yet. Discussion whether GISERA could provide a fact check to information that community may have questions about. NSW Health representative not attending the Coal Seam Gas and Public Health Conference being held in Narrabri on 15 August. DPE Update	 DPE representative advised that they had received additional submissions in relation to topics including waste, groundwater and fugitive emissions and Santos would be given an opportunity to respond to the matters raised and that will form part of the assessment documentation. The applications for Modification 6 Narrabri Coal Seam Gas Utilisation Project and the Modification 2 Dewhurst Gas Exploration Pilot Expansion were currently being assessed.
Santos presentation	 A Santos representative provided a presentation that was requested by a committee member at the last meeting as was made to the Narrabri Shire Council in February 2017. An additional slide in relation to expected employment associated with the Narrabri Gas Project was also included from Chapter 27 of the EIS. A copy of that chapter was distributed to members in hard copy. Committee was advised that further appraisal activities would occur in the Project area in the first phase of the Project. Preference to expand the generation capacity at the Wilga Park Power Station to use gas beneficially rather than flaring. This prompted a discussion on options of local electricity generation.
