EPA Update	<ul> <li>EPA advised that the Government had recently considered Recommendation 9 of the Final Report of the Independent Review of Coal Seam Gas Activities in NSW in relation to Environmental risk &amp; responsibility and insurance arrangements for the NSW CSG industry. In February 2020, the NSW Government released the report Safeguarding future environmental liabilities from Coal Seam Gas Activities in NSW to address the NSW Chief Scientist and Engineer's recommendation. More information is available from the EPA website at the link below.</li> <li>An EPA representative provided draft Narrabri CCC EPA Newsletters which will be available when finalised on the EPA website and through newsletter subscription.</li> <li>EPA has undergone a restructure and has moved to a functional model. EPA continues to be the lead regulator for the gas industry in NSW.</li> <li>A community member asked for an update from EPA on the number of complaints referred to them relating to the Narrabri Gas Project. EPA advised that complainant details would not be made available but the number of complaints may be advised.
