EPA Update	<ul> <li>An EPA representative responded to Action Item 42.1 to advise that a summary of the postcodes for complaints made to EPA relating to Narrabri Gas Project would not be provided as it may enable identification of individuals. A community member expressed disappointment that the information was not provided and the comment was noted.</li> <li>EPA organizational restructure is complete with the Gas Regulation Branch integrated into the core business structure of the EPA. The Narrabri Gas Project is administered by largely the same team that now sit in the Middle West Regional structure.</li> <li>Presentation/Handout/Links:</li> </ul>

DPIE Update	<ul> <li>A DPIE representative advised that the Narrabri Gas Project assessment report has been finalised and will be shortly referred to the Independent Planning Commission (IPC). There is a 12 week timeframe from receipt of the report for the IPC to make a final determination unless the IPC request a change to the timeframe.</li> <li>There are COVID-19 restrictions in place that will affect how Public Hearings are held and the IPC will provide more information on their website in relation to Hearing format. It is anticipated that the Public Hearings for the Narrabri Gas Project will be held at the end of July or early August. There will be two Public Hearings for other projects being assessed by the IPC prior to the Narrabri Gas Project and this will guide the technical framework for electronic hearings. Community members asked about opportunity to access Hearings as observers through a link and DPIE representative will refer this to the IPC for their consideration.</li> <li>Santos has advised DPIE that they will be submitting a modification for the extension to operate the Dewhurst Pilot wells.</li> <li>Presentation/Handout/Links:</li> </ul>

Division of Resources and Geoscience	<ul> <li>A DRG representative provided an update to Agenda Item 42.2 to advise that the responses to the Options Paper that was distributed for review and comment relating to the existing arrangements for the Community Benefit Fund had been considered. There were around ten submissions received including some new ideas and options.</li> <li>Draft guidelines incorporating feedback for the Narrabri Gas Community Benefit Fund has been prepared and is with senior government representatives for consideration and approval for distribution to stakeholders for consultation. A copy will be provided to CCC members for consideration when approved.</li> <li>The fund will not be instigated until the Narrabri Gas Project assessment is complete and Santos request the fund to be triggered. The fund guidelines and an Order for the gazettal will be prepared ready for when the fund is triggered.</li> <li>DRG will attend a future meeting of the CCC to brief members when the guidelines are approved for consultation.</li> </ul>
