## Community Investment Program Highlights



### Narrabri Carp Muster

A beautiful day and carp on the bite provided the perfect conditions for this year's annual carp muster held by the Narrabri Amateur Fishing Club on 4-5 March.

Narrabri Shire's waterways are now cleaner and freer of introduced European Carp with the Narrabri Shire community strongly supporting this event with six hundred and seventy-three competitors taking part.

As part of the event, the fishers were spread out across a number of waterways within the Shire, including Narrabri Creek, the Namoi River and its tributaries, and returned to The Crossing Theatre for weigh-in and carp counting.

In a massive haul, approximately 4700 carp of various sizes weighing 2420kg were removed from the waterways. Upon recycling the haul, it will be used as fish food for the native fish population at the Narrabri Fish Farm, which will then be released into north western NSW waterways to revitalise Murray Cod, Golden Perch, and Catfish populations.

European carp remain a major issue for Australia's inland waterways. Carp contribute to environmental degradation in the Basins. Reported impacts include reduced water quality, river bank damage and they may contribute to algae blooms. The increased spread of carp and its impact on freshwater habitat has come at the expense of native fish species and aquatic vegetation.

The event was again highlighted by the generous support of local businesses, such as Santos, and individual donors. An impressive array of prizes was funded by the supporters, and the ecstatic faces of the young anglers as they received their prizes demonstrated the kids' enthusiasm for the annual event.

Narrabri Amateur Fishing Club volunteers worked tirelessly throughout the weekend to make this event possible. There is much to organise and many details to be covered leading up to and on the even more busy weekend's finale prizegiving.

Narrabri Carp Muster is an outstanding community-driven environmental initiative that Santos is proud to support.

## Hunter Gas Pipeline

On 11 August 2022, Santos announced the acquisition of Hunter Gas Pipeline Pty Ltd which owns an approved underground gas pipeline route from Wallumbilla in Queensland to Newcastle in New South Wales. The underground pipeline route passes close to Santos' Narrabri Gas Project and our goal is to work with infrastructure developers and owners to construct the pipeline and deliver much-needed gas to east coast domestic markets in the shortest timeframe possible. The pipeline will also be designed to transport hydrogen as customer demand evolves during the energy transition. In order to transport, a modification to the existing approval would be required.

Our land access team continues to reach out to landholders and are making every effort to contact all landholders along the route to ensure they have an opportunity to ask questions or provide feedback about the proposed pipeline alignment. Land survey investigations will assist in the design and environmental assessment of the potential pipeline alignment. Land survey investigations are non-invasive and have minimal impact on daily landholder operations. We hope to reach voluntary access agreements with all landholders.

In January 2023, the NSW Government approved an Authority to Survey (ATS) application that was lodged in July 2022.

Santos will only use the ATS as a last resort in instances where all reasonable attempts to contact and negotiate access with the landholder or resident for the purpose of field surveys have been unsuccessful. ### Community Consultative Committee

A condition of the IPC consent for the Narrabri Gas Project is the establishment and operation of a Community Consultative Committee in accordance with the Department's Community Consultative Committee Guidelines: State Significant Projects. The NSW Department of Planning and Environment has appointed Mr Garry West to the position of Independent Chair of the committee.

The purpose of a Community Consultative Committee is to provide a forum for discussion between a proponent and representatives of the community, stakeholder groups and the local council on issues directly relating to a specific State significant project.

### NGP Advisory Groups

## Narrabri Lateral Pipeline

The Narrabri Lateral Pipeline will connect the approved Narrabri Gas Project (NGP) and Hunter Gas Pipeline (HGP), transporting natural gas to the existing transmission network near Newcastle.

On 9 December 2022, the NSW Government declared the Narrabri Lateral Pipeline a Critical State Significant Infrastructure project on the basis that it is deemed essential to NSW for economic reasons.

Secretary's Environmental Assessment Requirements (SEARs) were issued by the NSW Government on 9 February 2023 which specify what issues are required to be addressed within the Environmental Impact Statement (EIS). Santos will prepare an Environmental Impact Statement, which will be subject to extensive community consultation and a full environmental assessment.

## Operations Update



### Drilling activities

Santos has commenced drilling of shallow water monitoring bores in line with project approvals.



### Pilot Wells

Bibblewindi East, Bibblewindi West and Dewhurst South pilot wells are all online.



### Leewood

Santos does not need to irrigate at this time and water is stored in the holding ponds at Leewood.



## Wilga Park Power Station

The Wilga Park Power Station is online.



## Other activities

Groundwater monitoring activities for Environmental Protection Licence compliance are ongoing.

Ecological surveys will be undertaken through March to support reporting obligations and planning for future activities.





## Project Approvals

### NSW Government

On 30 September 2020, the NSW Independent Planning Commission (IPC) approved the Narrabri Gas with the Commission concluding that the Project is in the public interest and that any negative impacts can be effectively mitigated with strict conditions.

### Australian Government

On 24 November 2020, the Federal Minister for the Environment approved the Narrabri Gas Project pursuant to Sections 130(1) and 133(1) of the EPBC Act, subject to conditions.

## Native Title

Santos notes the determination of the National Native Title Tribunal handed down on Monday 19 December 2022, that proposed future acts, being the grants of Petroleum Production Lease Application Numbers 13, 14, 15 and 16 for the Narrabri Gas Project, may be done. On 13 January 2023, the Gomeroi People filed an appeal in the Federal Court of Australia in respect to this determination.

The Tribunal imposed a condition, in each case, that Santos takes all necessary steps to ensure the Additional Research Program – as identified in paragraph 5.7 of the Narrabri Gas Project Aboriginal Cultural Heritage Management Plan – be implemented. This must be completed prior to the commencement of Phase 2 of the Narrabri Gas Project, pursuant to the Development Consent granted by the Independent Planning Commission of New South Wales on 30 September 2020.

Santos will continue to engage constructively with the Gomeroi people and work closely with them to ensure their heritage is protected and they benefit from the project development in a range of ways, including through training and employment, and involvement in all aspects of their cultural heritage protection and management.

Santos has a strong track record of working collaboratively with First Nations peoples in Australia and internationally. The company has a range of cultural heritage and native title agreements in place with 23 Traditional Owner Groups and six Aboriginal Land Councils around Australia.

Santos has been consulting and working with the Gomeroi people since 2012, and in formal negotiations regarding the Narrabri Gas Project since 2015.

Narrabri natural gas is essential to ensure Australia's energy transition to renewables and cleaner energy technologies maintains both energy security and affordability for all Australians over the coming decades.
