## Executive summary

Australian Coalbed Methane Pty Ltd and Santos QNT Pty Ltd have appointed Santos as the operator for Petroleum Exploration Licence (PEL) No. 12. This report has been prepared by Santos to meet Condition 2 of the Petroleum Exploration Licence which states that the licence holder must carry out community consultation in relation to the planning and conduct of activities under this licence in accordance with the *Exploration code of practice: Community consultation*, Department of Regional NSW.

During the reporting period, the work program for PEL 12 has focussed on tenure management, progressing scouting activities to support future work program commitments and consulting with the community more broadly about Santos' activities in NSW.

Desktop studies and reviews have been conducted to meet the current work program commitments for PEL 12 in accordance with the instrument of renewal. Community consultation has been undertaken to support this work program. Santos' ongoing community consultation and engagement program continues to:

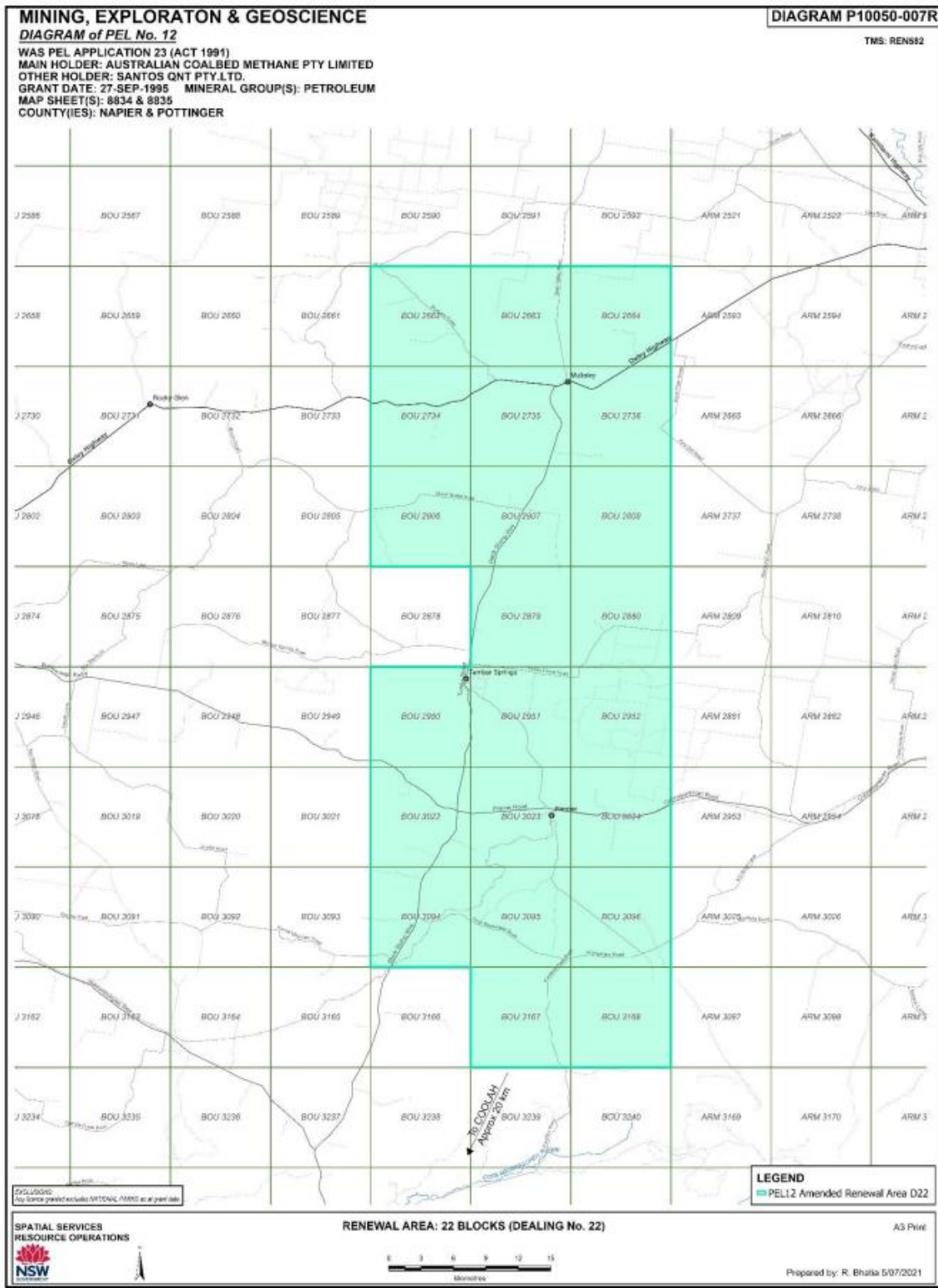
- Provide opportunities and information to stakeholders and the broader community about how to engage and provide feedback.
- Implement the consultation framework with regards to the exploration program, size and scale of the project and access to associated information and resources.
- Maintain relationships with Aboriginal community members through consultation with relevant parties and increase knowledge of the gas industry, specifically Santos' work program in NSW.
- Implement strategies to mitigate, manage and minimise the risk of conflict.
- Resolve issues as they arise.

Santos maintains a community shopfront in Narrabri with staff available to provide information, answer questions or address concerns that stakeholders may raise. A Monthly Activity Update is emailed to subscribers and published in the Narrabri Courier, Gunnedah Times, and Wee Waa News. Updates are also provided to the broader community regarding key activities and milestones through Santos' website, social media channels and media releases.

The key areas of interest for stakeholders and the community during the reporting period included proposed exploration and appraisal activities in the licence area and Santos' broader activities in New South Wales, groundwater management in relation to the Great Artesian Basin, drilling and well integrity, and potential impacts to existing land uses through coal seam gas (CSG) development.

There have been no complaints recorded for activities within PEL 12 during the reporting period.

## Annual work program

Petroleum Exploration Licence (PEL) 12 was granted on 27 September 1995 and was renewed 12 April 2022 for a further period of six years. Santos Limited, through its subsidiary entities, is the CSG operator for the wider contiguous exploration project currently consisting of PEL 1, PEL 12, PEL 238 and PEL 427.

The work program for PEL 12 which covers this reporting period has included desktop activities, environmental assessments, geological studies, community engagement (including resources and information provided at the Narrabri shopfront and Narrabri Gas Project and Santos websites), tenure management and reporting to keep the tenure in good standing.

## Regional context

PEL 12 is located in the southeast part of the Gunnedah Basin in New South Wales and consists of 22 graticular blocks. Major centres in close proximity (but outside of the PEL) include Coonabarabran (approx. 45km west) and Gunnedah (approx. 30km northeast).

PEL 12 is within the Federal Government electoral boundaries of Parkes, the State Government electoral boundaries of Barwon and Tamworth, and the Local Government Areas of Warrumbungle Shire, Gunnedah Shire, and Liverpool Plains Shire. The Gomeroi People's Native Title claim extends over the PEL 12 tenure area.

## Consultation summary

At this stage of the exploration and appraisal program, the annual work program is focused on desktop activities, environmental and geological studies to support tenure commitments. Additionally, there is ongoing communication with the Longlea 1 landholder concerning biosecurity management and monitoring activities.

Throughout the reporting period, participation in community events and the opportunity to offer community site tours has continued. Santos has attended a number of events including AgQuip, Gunnedah Show, Gunnedah Rugby Union Grand Final and the Gunnedah Youth Week Expo. Santos maintains a community shopfront in Narrabri with staff available to provide information, answer questions or address concerns that stakeholders may raise. A Monthly Activity Update is emailed to subscribers and published in the Narrabri Courier, Gunnedah Times, and Wee Waa News. Updates are also provided to the broader community regarding key activities and milestones through Santos' website, social media channels and media releases.

Significant work has been done to offer insights into the wider NSW gas industry and to address any inaccurate or misleading information. Santos has systems and processes in place to ensure that communities and stakeholder groups are provided with accurate information to understand the nature of the project and the likely impacts and benefits that may be derived from the project operations well before any on-ground activities are undertaken.

Santos utilises various engagement methods to recognise and address community concerns, ensure that identified community stakeholders are informed of the proposed schedule for implementing the approved work program, ensure stakeholders are notified prior to the commencement of relevant activities and that community consultation feedback is monitored and responded to.



## Stakeholder identification and consultation undertaken

Identification of key stakeholders for PEL 12 has been undertaken with stakeholders grouped according to their level of interest in the work program and the potential level of impact that exploration and appraisal activities may have and the expected level of participation.

Stakeholder groups include:

- Local, state and federal government departments and elected representatives
- Industry groups and regional organisations
- Landholders
- Local Aboriginal communities and Aboriginal Land Councils
- Local community
- Local business and contractors
- Media

## Summary of consultation

During the reporting period, activities have been undertaken in accordance with the *Exploration code of practice: Community consultation*, Department of Regional NSW. Desktop studies and reviews have been conducted throughout the period to meet tenure commitments. Consequently, due to the nature of these activities, the potential impact to the community and stakeholders within PEL 12 is very low.

All feedback collected during consultation is recorded in Stakeholder Relationship Manager (SRM). The data collected is then used to inform business decisions and develop future consultation strategies.

Santos' engagement with the Gomeroi people during the reporting period has been primarily related to progressing Native Title negotiations for the Narrabri Gas Project, Hunter Gas Pipeline and Narrabri Lateral Pipeline projects, engagement through the Narrabri Gas Project Aboriginal Cultural Heritage Advisory Group and

Aboriginal Cultural Heritage Working Group (cultural heritage scouting activity) and providing updates on proposed exploration and appraisal activities.

As the work program for PEL 12 has focussed on tenure management, the level of engagement specifically related to PEL 12 has been low, though Santos will continue to engage with the Gomeroi people as future work programs are proposed.

## Analysis of issues raised

With no on-ground works conducted within the licence area of PEL 12 during the reporting period, the majority of enquiries received have been general in nature, relating to the Narrabri Gas Project or activities being undertaken in PEL 1, the Hunter Gas and Narrabri Lateral Pipelines, the natural gas industry more broadly or requests for sponsorship contributions by local community groups. When questions on a particular topic are common, a technically comprehensive response is prepared so that information can be provided for future enquiries through fact sheets or other information shared via the website and shopfront displays.
